INFORMATION

Clients and their associated third parties agree to treat the surrounding environment, all property, and persons with respect. Any damages may result in a fee and or loss of deposit.

Reservations are required at least 2 nights in advance. All reservations are nonrefundable beginning 10 hours after your booking. Short Term Pro Glamping packages are for 19 hours, set within both parties agreed timeframe, not including time for setup and breakdown.

Any bookings over 2 nights are considered Long Term Pro Glamping packages and will require an additional fee and unique deposit, set by the company at that time.

We do not supply venue locations for events, but feel free to ask about our event planning services, if you would prefer for us to book the ultimate venue for you!



Party For Our Planet LLC is not liable for any damages to one's self or property, or any third party selves or properties, while associating with our company in any way. Client accepts full responsibility for all outside and third parties, including any third party damages or other incidents.

BOOKING INFORMATION

Events and services are forecast dependent, and are rain or shine. A free POP Up tent is provided for rain events. All Pro Glamping tents include a rain cover. All event times will vary. A fee will be added every 30 minutes required after your event end time.

In case of weather that the company deems inclement, or other unexpected circumstance from either party, a renewed date will be given, based on the company's booking calendar (subject to change), and the client's additional availability. In case of an unlikely double booking, the first assigned will keep that date, while the other will receive a renewed date.

We must be given immediate contact to any outside companies or persons your party is associating with, including but not limited to any venue hosts, caterers, etc. A copy of your driver's license or government ID is required for all rentals and reservations. Drivers license copies are not used in any way other than for company protection. We do not share your information without your approval in any way, unless required by law.

Each event and Pro Glamping package is set for a designated number of guests, with an additional cost for each guest after. You will be charged for guests that are unaccounted for ahead of the event for their normal rate plus an additional fee.



PRICING INFORMATION

Party For Our Planet is not responsible for any refunds in any way, including if the client deems the given products and services are unusable, inexact, unpreferred, or the like. We pride ourselves in providing our clients with a beautiful and worry free experience. Service fees are already included in all event & Pro Glamping packages. All standard service fees are adjusted per items and services requested. Service fees start at 10%. All pricing is subject to change at any time.

Billing for services and packages is separate. Security deposits are required for all bookings, and are set based on client requests. All deposits are fully refundable after your rental or event duration, pending approval from the company. Please allow up to a week's time for approved security deposits to be returned. Payments for deposit minimums are through our Online Booking System. This also reserves your event date. All other charges will be provided through an invoice. All client payments must be fully complete 24 hours prior to your event. Failure to complete full payment may result in service cancellation. Cash, Card, PayPal, and Venmo all accepted.

FOOD & DRINK


DETAILS

If there are specific food allergies in your party please let us know. Complimentary snacks and drinks do not affect package pricing, are selected at random, and will not be included if requested. Please note, consumer discretion is advised. We do not sell alcohol in any way. Proof of age & valid ID required. Events containing alcohol are exclusive to those 21 or older. Please note "Champagne" is only a package name.

It is not required for champagne to be given with any package and it does not affect pricing in any way, it is only complimentary as a gift from your event host, if included. Price variants come solely from the extra required furniture, decorations, resources, physical requirements, time needed for setup and breakdown, and so on. Please do not drink while maintaining a fire. Please drink responsibly. More information on our alcohol policy can be found in our Formal Professional Services Agreement.

All food, drink, and alcohol services are through our catering partner Sunday's Catering. Party For Our Planet is not a catering company. All food handling and distribution is in accordance with all food, drink, and liquor safety regulations and certifications. EQUIPMENT INFORMATION

Not all equipment is required to be set up, such as games, hammocks, blow up couches, electrical cords, or others. However, please note this will not always be the case. Providing our clients with the most comfortable and enjoyable event experience possible is our top priority. All items must be returned at the end of the rental duration, or a late fee will be issued to the client.

Standard setups include 15 interior and exterior items like faux plants, mirrors, rugs, vases, and art. Deluxe setups have 25 items, and themed decor is available upon request for an additional fee.

Additional decorations and full decor packages are also available. We strive to provide the requested items, but specific decor cannot be guaranteed. Decorations are chosen based on client preferences and company discretion, with the aim of creating a fun and aesthetically pleasing experience. Each event setup will differ and may not replicate photos. View our Full Inventory List for additional details on decor.

POP up tents and projectors are required to be on flat land, outdoors, with space that is at least 16x16x18 ft.

We require at least a 20x20x18 ft. space for all Standard Pro Glamping & events rentals and 30x30x18 for Deluxe & Group rentals, varying per venue occupancy. Event capacities and capabilities are completely dependent upon venues.

EQUIPMENT

INFORMATION

We do not offer any generator or power source. You or your designated location must have an electrical outlet available in order for lights and any electrical features to work.

Our projector is HDMI based. It does have additional settings (AVI, USB, etc.) but we do recommend HDMI. An attachable CD player is available for an additional fee. The projector will always be set up by your event host and will require the necessary 16x16x18ft space.

We will cover all travel costs up to 100 miles total from Chesterfield, NJ. An additional .50 cents per mile will be added to final payments for every mile after.

Guests are responsible and liable for all equipment & electronics if there is no event host present, including making sure equipment is safe overnight and through inclement weather. This is not including special circumstance as deemed relevant by the company. Clients are responsible for any damage, theft, or loss of equipment while it is in their possession, including those caused by third parties or external entities.
